**STATEMENT OF COOPERATION (READ CAREFULLY)**

In making application for my child, it is my desire for him/her to be enrolled in O.B.C.S. and to participate in the entire school program. He/she has my permission to go on all field trips and activities pertaining to the educational program sponsored by the O.B.C.S. It is my understanding that tuition is due one month in advance on the first of the month for the following month, and that **unpaid balances will be charged a \$35.00 fee after the 10th of the month.** Activity and book fees are non-refundable after July 1. Students that enroll after the official opening of school in the fall will be charged for the exact number of days enrolled in the school year, plus the full matriculation fee. On the day of enrollment, the matriculation fee plus one adjusted month tuition is due. The balance of the tuition will be divided into equal monthly payments beginning the 1st of the next month through May 1. Tuition or fees owed to the school must be satisfied in full before semester exams can be taken or academic records released. Report cards and grades may be held by the school at any grading period until an account is brought up to date. A student is subject to suspension when tuition has been delinquent for 30 days, until the account is made current. Unused paid tuition will not be refunded unless the student moves making distance impractical or a doctor's statement assuring O.B.C.S. that because of sickness the student needs to be dropped from the roll.

To the best of my knowledge the above information is accurate and reliable. Fraud will result in dismissal of my child and forfeiture of all tuition and fees paid.
